Main goals of a Forum:

Understand a problem in the community

Deliberation (open to all equally – everyone has a voice; respect for all voices)

Benefits for all rather than a few

Getting to Consensus

Taking the consensus out into the world



Why this program title?

Because YOU are needed for a discussion about access to doctoral education (and retention). This program is arranged to share knowledge, skills, abilities, and expertise in this area.



Problem

Because "Doctoral education's diversity record is poor" (Woodrow Wilson Fellowship Foundation (US), 2005, p. 3), and "it's getting worse" (p. 3) access and attrition are two pressing problems for diverse women and men in colleges of education.

Survey of Earned Doctorates (SED) in US

2005

Over 45,000 doctorates earned

15,000+ doctorates earned by non-U.S. citizens

1,529 doctorates earned by "other" minorities (Native American, African American, Asian Americans, etc.)

Purpose of Workshop

The purpose of this workshop is to open to teacher educators, educational leaders, policy makers, and administrators an opportunity to have face-to-face dialogue with other interested parties to discuss lack of access and lack of retention in graduate programs by the diverse International women and men attending the World Assembly who would like to focus their attention on issues and solutions for doctoral education.
